

Worksheet 1. Expressionist Techniques (Teacher Version)

Expressionist techniques in modern theatre:

- Internal experience that is subjective, not objective or real
- Fragmented characters that are often social or spiritual archetypes
- Abstract space/time that is suggestive and symbolic, not explicitly stated
- Atmospheric lighting that is expressive of emotion
- Spatial devices that are suggestive and symbolic, not explicitly stated (i.e., staircases)
- Acting style that includes expressive movements and loud utterances

Tennessee Williams used these characteristics to relate the following themes:

- Reality is subjective;
- “Memory” is valuable;
- Modern urban culture is dehumanizing and grotesque
- Life in mid-20th-century America causes angst

Instructions: Enter the information requested in the boxes for each of Williams’ expressionist techniques. The techniques have already been listed for you in Column 1.

Column 2. Give one example of each technique from the play using quotations from the text.

Column 3. Indicate “toward what ends” Williams was driving when he included that expressionist technique in *The Glass Menagerie*—tell which theme he was trying to get across to the audience or reader.

In the space below write your initial thoughts about the connections between the examples and Williams’ themes. Use quotations from the text.

Note that some of your examples may illustrate more than one theme. Put them wherever they fit, but be sure to answer “toward what ends?” for each.
